MEMORANDUM OF ORAL DECISION DELIVERED BY STEVEN STEFANKO ON MARCH 24, 2015 AND ORDER OF THE BOARD

INTRODUCTION

[1] On July 15, 2014, County Council passed Zoning By-law No. 1-Z-2014 ("CZB") which consolidated the zoning by-laws for the former municipalities of the Township of Norfolk, the Township of Delhi, the Town of Simcoe and the City of Nanticoke.

[2] Subsequent to the passage of the CZB, 14 appeals were filed by various individuals and corporations pursuant to s. 34(19) of the *Planning Act.* This prehearing was conducted to begin dealing with the various appeals which have been lodged.

SETTLEMENTS

[3] At the commencement of this proceeding, I was requested to approve five site specific appeals which have been settled with the County. The five appellants are NRV, Royal Clover, Ms. Scruton, TDL and Livingstone.

[4] In relation to the settlements reached, Pamela Duesling, Senior Planner/Manager of Community Planning for the County, filed a detailed affidavit ("Duesling Affidavit") in support thereof. The agreed upon amendments ("Site Specific Amendments") are attached to the Duesling Affidavit and marked as Exhibits B to and including Exhibit F.

[5] Specifically, the following Exhibits relate to the following parties:

- (i) NRV...Exhibit B;
- (ii) Royal Clover...Exhibit C;
- (iii) Ms. Scruton...Exhibit D;
- (iv) TDL...Exhibit E; and
- (v) Livingstone...Exhibit F.

[6] In the opinion of Ms. Duesling, the amendments to the CZB reflected by the settlements reached, are consistent with the Provincial Policy Statement, 2014, conform to the County Official Plan, represent good planning and are in the public interest.

[7] Based on the un-contradicted opinion of Ms. Duesling and the submissions of the parties involved, it is ordered that the CZB is amended in accordance with the Site Specific Settlements.

ADDITIONAL / WITHDRAWING PARTIES

[8] During the course of this proceeding, Mr. Keith Jones indicated that he represented a number of parties who supported the County's position in relation to the appeal filed by Georgia and Kenneth Painter ("Painter Appeal") and that he represented one Robert Hunter who also supports the County's position with respect to the appeal filed by Kenneth Zurby ("Zurby Appeal"). As such, he was seeking party status for his clients in relation to those appeals.

[9] On the basis that there was no opposition to the request of Mr. Jones, it is further ordered that:

Jack Matthews Marine Service Limited, Meika Matthews, Pete Spencer,Jan and Peter Overend carrying on business in partnership as Port Dover

Boat Works, John and Kathy Fleet, Gord and Vera Ellis, Rob and Brenda Vary, Chuck and SherylLynn Powell and Nadra Marine Services Limited are all made parties to the Painter Appeal: and

(ii) Robert Hunter is made a party to the Zurby Appeal.

[10] A letter from Thomas Cline, counsel for one Tina McLaughlin, was also filed at this prehearing and marked as Exhibit 3. Mr. Cline indicated that the appeal filed by his client ("McLaughlin Appeal") in relation to the CZB was being withdrawn.

OTHER MATTERS

[11] The County also indicated that, although settlement discussions are ongoing with a number of appellants, two days should be set aside in the near future to hear the Painter Appeal and the Zurby Appeal, to deal with any additional settlements reached, to hear any motion brought and to schedule other hearings as may be required (collectively "Other Matters").

[13] Accordingly, it is further ordered that:

- (i) July 13 and 14 are hereby set aside to address the Other Matters.
- (ii) Proceedings shall commence at **10:30 a.m. on July 13, 2015 at**:

Council Chambers County Administration Building 50 Colborne Street South Simcoe, ON N3Y 4N5

and the County shall make the necessary room arrangements; and

(iii) No further notice is required.
